## **NOTICE OF PUBLIC HEARING**

Notice is hereby given that the City Council of the City of Martinez will hold a Public Hearing in accordance with the Martinez Municipal Code, on

PLEASE TAKE NOTICE that on October 17, 2018, at 7:00 p.m. in the Chambers of the City Council of the City of Martinez located at 525 Henrietta Street, Martinez, CA, the City Council of the City of Martinez shall consider adopting an ordinance, which has as its purpose the extension of an existing moratorium which, without extension, will expire on October 31, 2018. The existing moratorium ordinance imposes a moratorium on all commercial cannabis activities except for a pending application for a medicinal cannabis dispensary. Said ordinance contains findings that its adoption is exempt from CEQA under CEQA Guidelines sections 15308, 15060, and/or 15061, among others. Said ordinance contains findings approving the issuance of a report describing the steps that have been taken and/or will be taken to alleviate the conditions leading to the adoption of the original moratorium on November 1, 2017, and its extension by the Council on December 6, 2017. This ordinance applies to all real properties located within the jurisdictional boundaries of the City of Martinez. At this public hearing, the City Council will be asked to extend the existing moratorium ordinance for up to 12 months, namely, up until October 31, 2019.

A copy of the full text of the proposed Ordinances is available for public review in the Office of the City Clerk during regular business hours.

Comments received on or before the public hearing date will be considered by the City Council. If anyone wishes to challenge this project in court, they may be limited to raising only those issues they or anyone else raised at the public hearing described in this notice or in written correspondence delivered to the Community Development Department at, or prior to, the public hearing.
