#### HOW DOES IT WORK?

The Martinez Police Department is committed to our partnership with residents and business owners. Many business owners and residents currently operate security systems at their businesses and/or homes. As crimes occur nearby, they are not always aware that their system may have captured information that could help solve the crime, thus keeping our community safer. In turn, the police are also not always aware who may have this potentially vital investigative information.

The Police Department is asking residents and businesses across the city to register their privately owned security camera systems. As the Police Department responds to criminal incidents in our community, they may be able to use the information or footage gathered from the security cameras to assist in the apprehension and prosecution of the criminals involved.

#### WHAT ARE THE BENEFITS OF REGISTERING YOUR CAMERA?

Registering your camera will help the police department identify cameras nearby any crime scene that may have captured criminal activity. After registering your camera, you would only be contacted by the Martinez Police Department if there is a criminal incident in the vicinity of your security camera. Police personnel, if necessary, may ask to view your camera footage in order to assist in the investigation. This will not only assist the Martinez Police Department in solving crime, but it will help keep our community a less desirable place to commit crimes.

#### REGISTER NOW

<b>Registration</b> Filling out the registration form is simple. We ask you to provide basic information regarding the location and direction of your cameras.	<b>Verification</b> Once you have completed the registration process you will be entered into a police database. A member of the Martinez Police Department will contact you to confirm the information is accurate.	<b>Call for Assistance</b> If registered, you would only be contacted by an officer if there is criminal activity in the vicinity of your camera. If necessary, police personnel may request a copy of video captured by your camera to assist in the investigation. The assistance you provide is still voluntary, and you can opt to deregister your system at any time.
