OWNER-BUILDER DECLARATION

EXEMPTION FROM WORKER'S COMPENSATION INS.

I hereby affirm that I am exempt from the contractor's license Law for the following reason (Sec. 7031.5), Business and Professions Code: Any city or county which requires a pennit to construct, altar, improve, demolish or repair any structure, prior to its issuance, also requires the applicant for such pennit to file a signed statement that he is licensed pursuant to the provisions of the Contractors' License Law (Chapter 9 (commencing with Section 7(00) of Division 3 of the Business and Professions Code) or that he is exempt therefrom and the basis for the alleged exemption. Any violation of Section 7031.5 by any applicant for a pennit subjects the applicant to a civil penalty of not more than five hundred dollars (\$500):

If, however, the building or improvement is sold within one year of completion, the owner builder will have the burden of proving that he did not build or improve for the purpose of sale).

SECTION 106A.4 CALIFORNIA BUILDING Code

Every permit issued by the Building Official under the provisions of this Code shall expire by limitation and become null and void, if the building or work authorized by such permit is not commenced with 180 days from the date of such permit, or if the building or work authorized by such permit is suspended or abandoned at any time after the work is commenced for a period of 180 days.
