

POLICE BLOTTER FOR MAY 1-15, 2021



On May 1st at 5:39 pm, the LPR unit captured a stolen plate on a vehicle traveling N/B in the 4400 block of Alhambra Avenue. Officer Green located the vehicle and effected a high-risk traffic stop. The subjects were detained. The driver was arrested for possession of stolen property and booked into county jail. Case# 21-931.

On May 2nd at 3:54 pm, MPD received a call from a male subject stating he was being chased/followed by someone he knows and the person was possibly armed. They were able to locate the female who was determined to have an outstanding arrest warrant. A search of her vehicle was conducted incident to the arrest. The search revealed a loaded "ghost" Glock semi-automatic pistol which was loaded with an extended round magazine. She was subsequently arrested and booked into county jail for the weapons violation and warrant. Case# 21-937.

On May 2nd at 9:48 pm, Officer Angoco initiated a traffic enforcement stop on westbound SR4, east of the Center Avenue off-ramp. A Richmond male was identified as the driver and sole occupant of the vehicle. Officer Angoco's observations directed him to initiate a DUI investigation. After the field test and PAS sample was completed, the driver was placed under arrest. He was transported to the station for booking paperwork and collection of blood evidence. After collection of blood evidence, the subject was booked into MDF. Case 21-939.

On May 3rd at 6:48 am, officers were dispatched to the 4100 block of Florence Dr. to investigate a vehicle theft. Sometime during the evening, a white Ford F250 was stolen from the front of the home. Case# 21-941.

A search warrant was obtained for blood evidence for the DUI. After being medically cleared, the subject was booked into county jail. No force was used during the arrest and no one was injured. Case# 21-1005.

On May 12th at 4:06 pm, officers responded to the Glacier overpass for a disturbance between 1st Amendment activists and members of the community. At some point, a male in an orange shirt tore down the display from the fence. The male left prior to PD arrival; however, there was approximately \$30 worth of damage to the group's display. A report was taken for the vandalism. Case# 21-1006.
