How to Register for the FALL Softball League

- Register online at www.martinezrec.org
- Teams must have a minimum of 12, maximum of 20 players on their roster.
- Limit of 9, non-resident players for each team. Managers can pay non-resident fee for each player at time of online registration.
- Each player is required to sign a player waiver BY their first game.
- Registration opens on **August 9th** and closes on **September 8th**.
- Late registration fee (after September 8th): \$25
- **Rosters will not be accepted without payment!**

Fee: \$585

City of Martinez– Player Waiver and Release of Liability Agreement

I, the undersigned player, acknowledge, agree and understand that:

1. Voluntary and of my own free will, I elect to participate as a member of the adult softball league indicated below.
2. I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, including but not limited to these hazards associated with weather conditions, playing conditions, equipment, and other participants.
3. I understand that the very nature of softball is hazardous and risky, including, but not limited to, the acts of throwing or catching the ball, blocking, running, jumping, stretching, sliding, diving, and collisions with other players and/or stationary object, all of which can cause serious injury or death to me or other players.

Further, I, the undersigned player, agree to that in consideration for the right to play as a member of the team designated below and in consideration for permission to play on the field arranged by the team or league:

1. I voluntarily elect and assume all the risks of injury incurred or suffered by me while (a) practicing as a member of the team designated (b) while on or upon the premises of any and all fields arranged by my team or league for practice or play and (c) while serving in a non-playing capacity as a team member during practice or play by other teams.
2. I release, discharge and agree not to sue the team and the City of Martinez, the Contra Costa Officials Association, Inc. or their officers, agents, servants, associations, employees or any other person or entity connected with the team, league, or field for any claim, damages, costs or cause of action which I have or may have in the future as a result of injuries or damages sustained or incurred by me from whatever cause.
