**Subject:** Measure D – Citizens' Oversight Committee Annual Report

## Recommendation

Receive update, hold discussion, provide input to staff and accept the Measure D Citizens' Oversight Committee Fiscal Year (FY) 2023-24 Annual Report and forward to the next available City Council meeting.

## Background/Timeline

On November 8, 2016, seventy-two percent (72%) of Martinez voters approved Measure D, to increase the sales and transaction tax by an additional one-half (0.50%) percent for 15 years to fund roadway projects. The measure was certified on December 7, 2016, via Resolution 093-16. On February 15, 2017, the City Council adopted Measure D Street Selection Policy, Resolution No. 019-17, and on April 1, 2017, Measure D went into effect and began to be collected on eligible transactions.

On January 31, 2018, the Franchise and Public Infrastructure Subcommittee held the first public workshop with interested residents regarding the Measure D funded Fiscal Year 2018-19 Annual Pavement Management Program. This workshop was held in accordance with the Measure D Street Selection Policy. Subsequent annual public workshops were held on January 23, 2019; January 22, 2020; January 26, 2021; January 18, 2022; January 30, 2023; and January 31, 2024.

At the February 4, 2025 workshop, staff proposed continuing to use a five-year rolling program of pavement preservation work (known as the StreetSaver® program) which adds a new fiscal year into the program as each annual pavement preservation project is completed. The Subcommittee recommended that City Council approve the proposed five-year pavement preservation program and the recommended FY 2025-26 Measure D Annual Pavement Preservation Project as the second year of this five-year program. On February 19, 2025, the City Council by Resolution No. 25-015 approved the Subcommittee's recommendations to adopt the proposed five-year pavement

preservation StreetSaver® program (FY 2025-26 through FY 2029-30) and to approve the FY 2025-26 Pavement Preservation Project.

### **Discussion**

The Fiscal Years 2025-26 through 2029-30 Capital Improvement Program (CIP) was adopted on May 7, 2025. In the CIP, the Council allocates funds only after they have been accumulated. Funding becomes available for expenditures to a project at the beginning of the fiscal year on July 1. On typical projects, the design begins during the fiscal year in which the funds become available. Depending on the complexity of the project, construction begins at the end of the fiscal year and can often run through a portion of the following fiscal year.

The City has allocated Measure D funds to the following projects in the current two-year capital budget for Fiscal Years 2025-26 and 2026-27:

### Measure D Projects Underway

C1076 (2023-24 Zone 2 Resurfacing Project) includes surface seal and pavement rehabilitation of streets selected under prior years 2022-24 of the Five-Year Pavement Preservation Program. Treatment methods for resurfacing includes slurry seal and cape seal, while asphalt overlay will be the treatment method for pavement rehabilitation. Streets selected for this project are located in southeast area of the City bounded by State Route 4, Morello Avenue and Chilpancingo Parkway. Construction was performed under two separate contracts, with the resurfacing project primarily located on residential streets, while pavement rehabilitation took place on arterial and collector streets.

On May 15, 2024, by Resolution 045-24 the City Council rejected bids for the 2023-24 Surface Seal Project C1076-1 and directed staff to re-advertise the project for bids. The project was readvertised and on June 26, 2024, by Resolution 103-24, the City Council accepted bids for the 2023-24 Surface Seal Project C1076-1 and awarded the construction contract to American Pavement Systems, Inc. from Modesto, CA, in the amount of \$2,106,300. Construction is underway and the project will be completed early this summer.

On June 5, 2024, by Resolution 075-24, the City Council accepted bids for the 2023-24 Paving Rehabilitation Project C1076-2 and awarded the construction contract to MCK Services, Inc. from Martinez, CA, in the amount of \$3,893,060. Construction is complete and the project will be closed out by the end of the fiscal year.

C1074 (Alhambra Avenue Downtown Paving) is a federally funded project that received \$846,000 of One Bay Area Grant 2 (OBAG 2) funds. Matching funds include \$360,000 of SB-1 RMRA Funds and \$240,000 of Measure D Funds. On October 2, 2024, by Resolution 144-24, the City Council accepted bids for the Alhambra Avenue Downtown Paving Project C1074 and awarded the construction contract to Rapid Grading Services from Hayward, CA, in the amount of \$1,081,451. Construction is complete and the project will be closed out by the end of the fiscal year.

C2014 (Morello Avenue Sidewalk Gap Closure) addressed sidewalk gaps on Morello Avenue south of Morello Hills Drive and at the northeast corner of the Morello Avenue and Arnold Drive intersection. Major funding is from Measure D of \$100,000, which serves as the match for the SB 1 LPP-F Grant of \$100,000. On September 18, 2024, by Resolution 131-24, the City Council accepted bids for the Morello Avenue Sidewalk Gap Closure Project C2014 and awarded the construction contract to Terocons, Inc. from San Francisco, CA, in the amount of \$310,278. Construction is complete and the project will be closed out by the end of the fiscal year.

C1077 (2024-25 Zone 3 Pavement Resurfacing project) will focus on streets in downtown Martinez and areas south up to Bush Street and Bertola Street. Bids were opened March 20, 2025, and the construction contract is scheduled for award at the May 21, 2025 Council meeting. Major funding is from Measure D of \$4,110,500, SB-1 RMRA of \$940,000, and an SB-1 LPP-F Grant of \$400,000

C1078 (Annual Pavement Study/Plan Updates) focuses on updating the annual selection of streets to be paved for the next five years, which is presented to the Street Selection Workshop and City Council in January and February every year. Funds from this project are also used to contribute towards the assessment of the street pavement condition and updates to the City's Pavement Management Program.

### **Oversight Committee Review/Financials**

Each fiscal year, the City is required to have a financial audit conducted by an independent certified public accountancy firm. The CPA firm of Maze and Associates is the City's independent external auditor. The City's Fiscal Year 2023-24 audit was completed in March 2025 in conformity with generally accepted accounting principles (GAAP). The auditors' opinion was that the financial statements fairly represent the financial position of the City as of June 30, 2024. On March 19, 2025, the audit was received and accepted by the City Council.

The Measure D Citizens' Oversight Committee Bylaws, as amended on March 20, 2019, and attached for reference as Attachment A, specifies the following as the Committee's purview with sections 3.1 and 4.1, respectively:

*3.1 Duties of the Committee. To carry out its stated purposes, the Committee shall perform the following duties:*

*(a) Inform the Public. The Committee shall inform the public regarding compliance of the City’s expenditures of Special Tax proceeds as specified in Measure D.*

*(b) Review Expenditures. The Committee may review quarterly expenditure reports produced by the City to ensure that (a) Special Tax proceeds are expended only for the purposes set forth in the ballot measure; and (b) no Special Tax proceeds are used for any administrative salaries of City employees or other operating expenses.*

*(c) Present Annual Report. The Committee shall present to the City Council, in public session, an annual written report which shall include the following:*

*i. A statement indicating whether the Committee has determined that the City has expended Special Tax proceeds only for the purposes set forth in the ballot measure; and*

*ii. A summary of the Committee’s proceedings and activities for the preceding year.*

*4.1 In order to perform the duties set forth in Section 3.0, the Committee may engage in the following authorized activities:*

*(a) Receive and review copies of the City’s annual independent audit of expenditure of Special Tax proceeds.*

*(b) Inspect City rights-of-way for which Special Tax proceeds have been or will be expended, in accordance with any access procedure established by the City Manager of the City.*

In accordance with the bylaws, the audited statements as of June 30, 2024, included as Attachment B to this report for reference, reflect the following amounts of income received and expenses incurred:

Measure D funding has contributed to the following pavement preservation projects, which have been completed on the following neighborhoods/streets:

FY 2018-19 Paving Project (C1061): On September 4, 2019, by Resolution 104-19, the City Council accepted the construction contract by MCK Services, Inc. in the final amount of \$2,103,446.66, which included \$1,351,300 from Measure D. The project included work at the following locations:

1. Glacier Drive – Muir to Olympic
2. Pine Street – South of Shell Ave (base failure repair)
3. Chilpancingo (base failure repair)
4. Miscellaneous streets (including Arlington, Huntington)

FY 2018-19 Measure D Pavement Rehabilitation Project (C1062): On September 4, 2019, by Resolution 105-19, the City Council accepted the construction contract by American Pavement Systems Inc. in the final amount of \$2,453,189.75. The project included work at the following locations:

1. Canyon Way & Castro/E. Street Area
2. Brookside Area
3. Brookside Expanded Area
4. Muir Estates Area 1

FY 2019-20 Paving (C1064): On November 3, 2021, by Resolution 146-21, the City Council accepted the construction contract by McGuire and Hester in the final amount of \$2,527,623.73. The project included work at the following locations:

- 1. Arnold Drive (west of Morello)
- 2. Howe Road (Pine to Vista)
- 3. Midhill Road (Morello to Forsythia)
- 4. Muir Road (Morello to Glacier)
- 5. Base Failure Repair in preparation for Cape and Slurry Seal (2019-22)
- 6. Various Streets paving
- 7. Mid Hill Rd from Morello to Forsythia
- 8. Muir Rd from Glacier to Morello
- 9. Arnold West of Morello

FY 2019-20 Measure D Pavement Rehabilitation Project (C1065): On June 17, 2020, by Resolution 063-20, the City Council accepted the construction contract by American Pavement Systems Inc. in the final amount of \$2,154,017.81. The project included work at the following locations:

- 4. Yale Street area
- 5. Morello Heights area

Three Cities Pavement Preservation (C1068): On December 21, 2022, by Resolution 202-22, the City Council accepted the construction contract by Bay Cities Paving and Grading, Inc. in the final amount of \$3,284,637.09. The project included work at the following locations:

Two Cities Curb Ramp Project (C1069): On February 16, 2022, by Resolution 018-22, the City Council accepted the construction contract by J.J.R. Construction in the final amount of \$732,161.95.

Fiscal Year 2022-23 Surface Seal Project (C1073-1): On October 4, 2023 by Resolution 127-23, the City Council accepted the improvements and the construction contract by American Pavement Systems in the final amount of \$766,888.12. The project included surface seal treatments to extend the life of the following streets:

Fiscal Year 2022-23 Pavement Rehabilitation Project (C1073-2): On February 7, 2024 by Resolution 010-24, the City Council accepted the improvements and the construction contract by MCK Services in the final amount of \$3,949,643.65. The project included pavement rehabilitation on the following streets:

- Arnold Drive: Old Orchard Road to 400 ft west of Shadowfalls Drive
- Arnold Drive: Morello Avenue to Gloucester Lane
- Howe Road: Vista Way to Pacheco Boulevard
- Old Orchard Road: Howe Road to Arnold Drive:
- Williamson Court: Arnold Drive to end
